### Development Plan Review Fees:

With any new development/construction project, PVFPD will collect a **non-refundable** Development Review deposit. The fee will be collected at the time of application. After approval of the initial development review, the project will move into the construction phase and appropriate fees will be collected. The amount of the deposit will go towards any additional Building or Site Plan Review fees and the remaining balance (if applicable) will be billed appropriately.

### Residential Subdivision Review

PVFPD reviews all submittals for proposed residential subdivisions, including single-family, duplex, and single-family attached. Plan review fees are assessed based on a count of the proposed number of fire hydrants in the subdivision as a means for estimating the time dedicated to review of submitted drawings and plats for compliance with the adopted fire code. Fees also provide for staff attendance at planning and engineering meetings, periodic site inspections, and correspondence and consultation related to the project. Additional fees shall not be assessed for resubmittals or changes made to the initial submittal.
